

## INSTRUCTIONS FOR FILLING OUT THE DEMAND FOR AUTHORITY FORM

For all those that want to help free your family member or friend that has been arrested by the federal system, the Demand for Authority form is your first step. The form may be found on the internet at [www.Fighting4Freedom.com/SOS](http://www.Fighting4Freedom.com/SOS). First go to the website and print out the form, then follow the instructions below to fill it out.

The first blank at the top of the page is the date. There you will put the date you are filling out the form. It is preferable that you spell out the month followed by the day and year. (e.g. June 20, 2006)

The next blank is *From*. That is where you put your name. Please put a complete address for yourself. Don't forget your zip code.

The next blank is *To*. There you will put the name of the Director of the arresting agency, e.g. FBI, DEA, local Sheriff's Department, Marshal's office, local Police Department, etc. Please put a complete address for the Director of the arresting agency. Don't forget the zip code.

The next blank is *Certified Mail #*. This will be the number from the certified mail receipt obtainable at any post office or postal service store.

The next blank is *Case Number*. This is the Case number of your family member or friend / associate that has been arrested, i.e., 3:02-CV-0605-R.

The next blank is *Dear*. Here, please put the name of the Director of the arresting agency. It should be preceded by a Mr. or Ms.

The next blank is *On*. Please put the date of the arrest of your family member or friend / associate. It is preferable that you spell out the month followed by the day and year. (e.g. June 20, 2006)

The next blank is where the form says *my*. Please put the relationship of the person arrested to you, e.g., son, daughter, father, etc.; plus their full name.

The next blank is *at*. Please put the complete and accurate street address of the place the arrest was made then complete the blanks for City, County and State.

When you have filled in all the blanks then you must sign the form.

Below your signature you will notice several names of people that need to have a copy sent to them. Alongside those names is plenty of blank space for you to add the names of any

other people you think a copy to should be sent to. For example a State Representative, any other news media, your Pastor, etc. Put in their names and complete addresses.

When you have completed the form, make enough copies to send to the Director, all the others listed and additional copies for your future use. Then send to all the names and addresses of the people you want to be notified of the Demand for Authority. Don't forget the four already typed. Keep any additional copies for your future use in sending to other potential people to notice them of the Demand. And of course always maintain a copy for your own record.

In the event the Director / Commissioner or other agency head in Washington, D.C. and fails to provide a timely response to your request, a letter to the Attorney General of the United States requesting a criminal investigation of the Director / Commissioner, etc., pursuant to 28 U.S.C. § 591 is in order.

In the event the Attorney General fails to take action, a request for appointment of Independent Counsel may be made pursuant to 28 U.S.C. § 592.

In the event Congress fails to appoint Independent Counsel, We the People may remove and replace Congress.
